## Incident #1: Sample Police Report

On Saturday, May 16, 2018, I was called to the incident at 12:05am. I arrived on the scene at 12:15am and interviewed the victim, Cher HOROWITZ (D.O.B 11/15/2000). HOROWITZ states she was approached by a white male (Suspect #1) while she was making a phone call in the parking lot of the Circus Liquor store on 10th and Elm Street in downtown Los Angeles. Suspect #1 looked to be approximately 25 years old with short brown hair and a goatee. Suspect #1 was wearing a gray hooded sweatshirt with a brown leather jacket over top the sweatshirt. While HOROWITZ was on the phone, Suspect #1 put the barrel of a handgun to her temple and asked for her phone. HOROWITZ gave him the phone. Suspect #1 lowered the gun to his side and asked for her purse. HOROWITZ handed him her purse. Suspect #1 told HOROWITZ to lie down on the ground. HOROWITZ refused saying that it would ruin her dress, a red Alaia brand dress worth \$500. Suspect #1 threatened to shoot her in the head, so HOROWITZ lay down, face down, in the parking lot. She was instructed, by Suspect #1 to count to 100. While she was counting she heard Suspect #1 run away. HOROWITZ states she could not see him running away, but it sounded as though he left running down 10th Street towards Oak Street. HOROWITZ stood back up when she counted to 24 and then used a pay phone in the Circus Liquor's parking lot to call the police station.

## Incident #2 Sample Police Report

On Saturday, May 16, 2018, I was called to the incident at 11:10am. I arrived on the scene at 11:48am and interviewed the victim, John DOE (D.O.B 1/27/1995). DOE states he was on the S.S. Generic Boat about to depart from the Boat Rides Are Us 100th Street port on its way to the Boat Rides Are Us East Street port. An unidentified while male (Suspect #1) came up to the deck where DOE and other passengers were seated. Suspect #1 looked to be about 25 years old with short light brown hair and a black leather jacket. He was wearing a gray shirt that buttoned at the collar and jeans. Suspect #1 stood by the steps that lead to the main deck and announced he was going to perform a magic trick by bending a spoon from a local restaurant. Suspect #1 stated he would give \$100 to anyone who could figure out his magic trick. DOE noticed a spoon in Suspect #1's back pocket and approached Suspect #1 to take the spoon out of his pocket and hold it up to show everyone Suspect #1 was not actually bending a metal spoon with his mind. DOE demanded the \$100 which he was given from a wallet he said looked like his own wallet. Suspect #1 quickly left the upper deck using the staircase behind them. DOE went to put the \$100 in his wallet when he realized it was missing. At this point he also realized his watch was missing. He looked over the railing to find Suspect #1 in the crowd to get his wallet and watch back, and saw Suspect #1 jumping from the boat to the dock just as the boat was leaving again.
